ACCESS TO VOTER REGISTRATION INFORMATION

Election Code Section 2187, 2188, 2194 Government Code 6254.4

Permissive Access

Persons who have access to voter information include those who are using the information for the following:

ELECTION PURPOSES: Voter registration information must be made available to anyone wishing to communicate with voters in connection with any election, or circulation of any recall, initiative, or referendum petition.

SCHOLARLY PURPOSES: Students working on a thesis, professors researching voting patterns and other academics involved in research.

JOURNALISTIC PURPOSES: Members of the press are permitted access.

POLITICAL PURPOSES: Communicating with voters to influence public opinion related to political or election activities. For example: Persons wishing to communicate with voters concerning legislation, vendors who provide information only to candidates, ballot measure committees, political parties and persons or organizations communicating with the voters about political issues whether or not this use is in conjunction with a specific election.

GOVERNMENTAL PURPOSES: Any request from a governmental agency or for a use related to a governmental function. For example: The Jury Commissioner, District Attorney, Public Defender or other public government agency.

RECORD REVIEW: For any person to conduct an audit of voter registration lists for election, scholarly, journalistic, political, or governmental purposes.

VENDOR: By any vendor to compile and/or organize voter registration information for another person's use.

Non-Permissive

Example of persons who do not have access to voter registration:

Persons (Such as relative, private investigators, skip tracers, process servers and attorneys) seeking to locate individuals, unless those persons are employed by or have been contracted by a public government agency; Solicitors of contributions or services for any personal, private, or commercial purpose; Any persons conducting surveys of opinions of voters other than those purposes permitted by the above mentioned Permissive Access.

INFORMATION FURNISHED ON THIS APPLICATION IS SUBJECT TO VERIFICATION

The Applicant hereby agrees that the aforementioned information set forth in Affidavits of Registration of voters and any information derived from said electronic data processing information (hereinafter collectively referred to as "registration information") will be used ONLY FOR ELECTION OR GOVERNMENTAL PURPOSES, or research as defined by Title 2, Division 7, Article 1, Section 19003 of the California Code of Regulations, and Elections Code Section 2194 and Government Code Section 6254.4.

The Applicant (as principal or agent) further agrees NOT to sell, lease, loan or deliver possession of the registration information, or a copy thereof, or any portion thereof, in any form or format, to any person, organization or agency without first submitting a new application and receiving written authorization from the Merced County Registrar of Voters to release such registration information.

The applicant and beneficiary, if applicable, agree to maintain information in a secure and confidential manner using best practices, and will notify the Secretary of State immediately of any violation, exposure, and/or breach of voter registration information and will cooperate with the Secretary of State's office or any investigative agency efforts related to any resulting investigation.

WILLFUL VIOLATION OF THESE PROVISIONS IS A MISDEMEANOR (ELECTIONS CODE SECTION 18109)

In addition, subject to provision of Title 2, Division 7, Article 1, Section 19001 through 19007 of the California Code of Regulations, the Applicant agrees to pay to Merced County Registrar of Voters, as compensation for any UNAUTHORIZED USE OF EACH INDIVIDUAL'S REGISTRATION INFORMATION, an amount equal to the sum of fifty cents (\$.50) multiplied by the number of times each registration record is used by the applicant in an unauthorized manner.
